Ken McVety, Public Works Supervisor attended and updated Council on several issues.

Downtown Core – Ken advised that the garbage cans downtown are being abused in some areas by people using them to dispose of household garbage. Ken would like to remove the garage cans with the exception of those in front of restaurants.

Clean Up – The former Rock N' Roll site has now been cleaned up and the timbers reused to build up the service dock at the marina.

Grassing Cutting – Having wear and tear issues with equipment, but parts are ordered and expected shortly.

Grader – By-passing oil. Ken received a shop rate of \$150 - \$160 from Strongco in Sudbury to look at the grader and troubleshoot the issue – estimated at 4 -5 hours. He also received a price of \$800 one way to float the unit to Sudbury.

- The grader would gone for about a week
- The estimate for a rebuilt motor is \$20,000
- There are currently 11,000 hours on the grader
- The seals are gone and oil is leaking into the motor
- The grader is a 1989
- Public Works would work this into their schedule
- If the grader is gone for an extended, would have contractor come in
- Would like to grade one more time before sending out grader
- Would like to get the grader out, get quote, work completed and back before gravel and culverts done on Crab Lake Road

Ann Street – Public Works has been working at cleaning up the trees that Hydro cut near Ann Street.
