Single Lot

- Permits interment of 4 cremated remains after the full interment.
- A single lot is allowed one upright monument and up to 4 markers and 4 corner posts, please refer to the Cemetery By-Law for maximum size.

Cremation Lot

- Permits interment of 1 cremated remains.
- Flat markers only are allowed on a cremation plot, an upright monument on a cremation lot is not permitted, please refer to the Cemetery By-Law for maximum size.

Niche Wall

- Unit can hold 1-2 cremated remains.
- Engraving on front cover is at the purchaser's expense and must be to the specs set out by the Mount Calvary Cemetery Board.

Marker Fee

- Total of the fees is deposited to the Care and Maintenance Fund
- Less Than 173 sq. in Nil
- Flat Marker over 173 sq. in or over \$100.00
- Upright - up to 4' \$200.00
- Upright - over 4' \$400.00

Supervisory Fee-Under Review

- \$25.00 per hour, minimum 1 hour charge
- Applies to all work conducted in the Cemetery which requires supervision, including:
 - Supervision of the removal of a monument or marker
 - Supervision of the installation of a new monument or marker
- Fee includes:
 - inspecting the installation of a marker or foundation
 - marking the location where a marker is to be installed

Interment Charges: No Burials Between Dec. 15th and April 1st unless weather permit an extension

- Includes opening and closing
- Includes registration of the burial
- All interments must be authorized in writing by the interment rights holder except the interment of the interment rights holder
- Interments after 4:00 p.m. on weekdays or after 3:00 p.m. on weekends are not permitted.

Full Burial

- A burial permit issued by the Division Registrar, showing the death has been registered and the fee for the opening of the lot, must be deposited with an official of the Corporation before interment can take place.
- Monday to Friday-\$240.00 between 9:00 a.m. and 3:00 p.m.
- Saturdays \$300.00 between 9:00 a.m. and 3:00 p.m.
- Sundays No Burials unless ordered by Ministry of Health

Amendment to Opening and Closing Fees Only

Effective January 1st, 2022

Cremated Remains (In-ground or Niche Wall)

- A cremation certificate and the prescribed fee for the service must be deposited with an official of the Corporation before interment can take place.
- Monday to Friday-\$**120.00** between 9:00 a.m. and 3:00 p.m.
- Saturdays **\$150.00** between 9:00 a.m. and 3:00 p.m.
- Sundays No Burials unless ordered by Ministry of Health

Winter Interment (December 15-April 1st) [Unless weather permits an extension]

- Monday to Friday-\$**500.00** * between 9:00 a.m. and 3:00 p.m.
- Saturdays **\$625.00** * between 9:00 a.m. and 3:00 p.m.

Disinterment Charges:

- Includes opening and closing

Full Burial

- Only permitted with a certificate of a Medical Officer of Health or the Corporation confirming that the Cemeteries Act and the regulations have been complied with, is affixed to the container.

\$500.00

Cremated Remains or Niche Wall

\$200.00

Winter – disinterment of remains are not permitted in the winter

Other Fees

Storage:

- Permits for the use of the storage vault must be obtained from the Secretary-Treasurer. In all cases when obtaining the permit, a deposit shall be paid sufficient to cover all expenses of interment (including purchase of lot if necessary)
- The deposit shall be refunded if the remains are not interred at the Mount Calvary

Amendment to Opening and Closing Fees Only Effective January 1st, 2022
